Information for California Proposition 65 "Wood Dust" WARNINGS for Lumber and Building Materials Producers, Distributors and Manufacturers

California's Proposition 65 law and the addition of "wood dust" to the list has implications for manufacturers, distributors and producers of wood products. A section of the law states: "to the extent practicable, warning materials such as signs, notices, menu stickers, or labels shall be provided by the manufacturer, producer or packager of the consumer products, rather than the retail seller." There are varying legal opinions on the application of a California state law outside the borders of the state, but any action, no matter what the outcome, is expensive and time-consuming. Our goal is to assist those involved in any segment of the wood products industry comply with this law to the best extent possible.

Producers, Distributors and Manufacturers are being strongly urged to inform their customers of the warning requirements for posting appropriate warning signs in retail outlets. It is also advised the language in the agreed-to warning sign be made available to the retailer, with an offer of additional signs from LACN or other sources.

LACN will maintain a confidential data base of businesses participating in this voluntary program and be available to confirm, as necessary, the business was furnished with the signs and information. As noted, the California Attorney General's office has agreed that if this program is followed by a business, it is their opinion this will satisfy the "clear and reasonable warning" requirement of the statute. While no one can prevent an action being filed by a third party or government agency, this program may assist in influencing dismissal of any action and deter such lawsuits.

LACN will have available on its website additional materials and information on Proposition 65 and compliance matters. Additionally, LACN will keep participating businesses apprised of future actions and will coordinate compliance with other wood products industry organizations and individual firms.
